1factor models - columbia university - 1factor models the markowitz mean-variance framework requires having access to many parameters: if there are n risky assets, with rates of return $r_i, i=1,2,\dots,n$, then we must know all the n means (r_i), n variances (σ_i^2) and $n(n-1)/2$ covariances (σ_{ij}) for a total of $2n + n(n-1)/2$ parameters. if for example $n = 100$ we would need 4750 parameters, and if $n = 1000$ we would need 501,500 ...
